

## Cyngor Cymuned Tregynon Community Council

Minutes of Tregynon Community Council's meeting held on 13 November 2025 at 7.30pm. *Present at start of meeting:* Cllrs M. Davies (Chair), T. Breese, M. Watkin, D. Bumford, H. Morris and the Clerk Rachael Jones. Apologies had been sent by Cllrs Hulme, Yeomans, Shearer and Williams. There were no declarations of interest.

*Minutes of October 2026 meeting:* These were read and accepted, with a small correction to details of traffic. The Chair then signed the minutes. *Matters arising:* *None.*

County Cllr Sian Cox attended to discuss Sustainable Powys, which is a plan to improve communication between the county council and local communities and community councils. Cllr Cox arrived at 7.40pm and spoke of her hopes that this would be an ongoing concept. Cllr Cox left the meeting at 8.20pm.

*Planning applications:* None. *Planning applications received after distribution of the agenda:* Ref.: 2025/1596/FUL Dry manure shed and access at Pwllan. The councillors considered this application and decided to offer no comment.

There was some concern about the development on Bettws Road at Tyn y Ddol. Clerk to look up the planning application.

*Remembrance Sunday:* The event went very well and was attended by about 25 members of the community. Cllr Bumford laid the wreath on behalf of the community council and read out the names of the fallen.

*Highways:* Local residents have reported grave concerns about the level of speeding. The clerk had earlier contacted the police about conducting more speed checks in the village, and the police response was that they checks will go ahead. Clerk to chase this up with the police. A concerned resident reported fouling on grass near her house. The councillors undertook to monitor the situation.

*Community Centre AGM:* Cllr Morris to attend.

*Cemetery:* Some remedial work to the wall and to a tree is needed. Clerk to obtain a quote for the tree work first from David Vickers.

*Playground:* The new equipment is in place. All the groups that provided funding are to be invited to a reception in December. *Playing field/amenity land:* Nothing.

*Finance:* Current account: £42,356.34; Reserve: 16,473.45. Three invoices were approved for payment: Clerk's fee and expenses (inc. poppy wreath) £662.50; Powys County Council (playground inspection) £78.00; Wicksteed (Playground equipment) £53,126.58. The invoices were approved and then signed by the Chair and Cllr Shearer. The clerk had earlier distributed a bi-monthly reconciliation. A grant of £12,000 towards the new play equipment was received from Dwyriw Community Trust. Clerk to buy a sympathy card for Jean Williams.
